The Board met in regular session at 9:00 AM. Members present: Vice-Chairman, Greg Moeller, Gary See and Marc Lindeen was absent.

It was moved by See and seconded by Moeller to approve the minutes of the July 27, 2017 Supervisors meeting. 2 ayes. Motion carried.

Jake Hotchkiss, Engineer, accompanied by Jelen McCall, office Manager gave the Secondary Road update. Road maintenance July 24th thru July 28th. Territory operators were in their blades, continued spraying roadsides for weeds and mowing shoulders. Continued working on concrete patching, worked on a couple entrances and started pulling shoulder project on Marsh Ave and hauled rock to Marsh Ave in anticipation of rain forecasted Wednesday. Worked on road signs and signs in former town of Mt Union, also worked on a small ditching project. Winfield Ave from Iris St to the west to Grand Ave is closed to through traffic, contractor has started working on storm sewer and removing pavement from Grand Ave to Detrick's Truck & Trailer Service. The Engineer wants to remind the public that Pilot is entered from Grand Ave and Detrick's Truck & Trailer Service, Liquid-grow, Mini Storage, Pioneer Seeds and East End Automotive are all open for business and have access off Iris St. Oakland Mills Bridge repair work, with Dormark Construction Co continues to have the Bridge over the Skunk River on W55 closed. Contractor will be installing new bearing plates today and plan to pour remainder of backwalls Wednesday and Thursday. County crew continues shoulder pull on Marsh Ave from Hwy 34 going south to the intersection of Logan Ave. Vice-Chairman, Greg Moeller signed the fuel contract with Cobb Oil Company, Inc effective today. Merrimac Rd directly west of Trenton will be closed starting Wednesday August 2, 2017. We will be scarifying the existing sealcoat and establishing a macadam stone base for approximately 600 feet we anticipate having project complete by Friday dependent on weather. Traffic will be routed from Merrimac Rd to 170th St during construction.
